Residents have asked us about the health impacts related to aircraft noise.	<ul style="list-style-type: none"> <li>• The human health impacts of aircraft noise falls under Health Canada's jurisdiction. The agency's last major study - Aircraft Noise in the Vicinity of Airports – was conducted in 2010.               <ul style="list-style-type: none"> <li>○ At that time, Health Canada determined "<b><i>there is insufficient evidence to conclude that aircraft noise causes heart disease. However, some studies suggest that people who live for many years in areas with intense traffic noise, may face a slight increase in the risk of developing heart disease. Health Canada will continue to assess future research on the potential health risks of aircraft noise</i></b>".</li> </ul> </li> <li>• At the request of residents, CENAC wrote Health Canada requesting an update to its 2010 report, assess the new research, and provide updated advice on the human health impacts of aircraft noise to Transport Canada.               <ul style="list-style-type: none"> <li>○ On October 13, 2017 Health Canada sent their response. The letter advised that "<i>while there are no immediate plans to update</i></li> </ul> </li> </ul>	The GTAA stands by its original position that it is time for an updated study on the health impacts related to aircraft noise. In early 2018, we will request a meeting with Health Canada representatives to further emphasize our request for an updated study.
